

Conditions of Entry

1. Entry into this competition is deemed as acceptance of these terms and conditions. Information on prizes and how to enter form part of these terms and conditions. Entries not completed in accordance with these terms and conditions are ineligible.

2. LAWNMOWER PURCHASER

Entry is open to all Australian & New Zealand residents who purchase a Masport Rotary Lawnmower (as nominated by the promoter), from a participating outlet, between 1st November 2008 and 31st January 2009 inclusive. Employees of the promoter, its associated companies, suppliers, distributors, agents and any member of their immediate families are not eligible to enter. Participating retail outlet staff and their families are not eligible for the 'consumer' game.

TRADE RESELLER

3. The scratch off card is divided into two sections;
